

**NOTICE UNDER PSL §122(2)(c)**

**TO ALL LANDOWNERS OF LAND ON WHICH ANY PORTION OF THE FACILITY PROPOSED IN ROCHESTER GAS AND ELECTRIC CORPORATION'S PUBLIC SERVICE LAW ARTICLE VII CERTIFICATE AMENDMENT APPLICATION TO THE PUBLIC SERVICE COMMISSION IS TO BE LOCATED:**

Rochester Gas and Electric Corporation (RG&E) intends to file an application (the Application) on or about February 10, 2020 with the New York State Public Service Commission (PSC) pursuant to Public Service Law Article VII requesting an amendment to the *Certificate of Environmental Compatibility and Public Need* issued in Case 03-T-1385 to allow RG&E to construct and operate its proposed Rochester Transmission Project Enhancement (the Project). The Project is the construction and operation of a new 115 kV transmission line (Line 949) for a total of 6.7 miles from Station 418 in the Town of Gates to Station 48 in the City of Rochester, and the expansion and upgrade of Stations 48 and 418. An approximately 0.3-mile section of Line 949 will be installed on double-circuit structures with existing Line 916, which was authorized by the PSC in Case 03-T-1385. RG&E proposes to locate the Project primarily along existing electric transmission and railroad rights-of-way (ROW). In some areas new transmission line ROW will be required to accommodate the Project and maintain required clearances. The Project also includes installation of stormwater management features; establishing one or more temporary laydown/staging areas and marshaling yards; and constructing or improving supporting access roads. The Project will allow RG&E to continue to ensure reliable service to customers in its Western Division.

Your property may be impacted by this Project.

After the Application has been filed, interested persons who wish to participate as parties in this case may file a request for party status. This may be done through the PSC's web site. From the home page of the PSC's web site (<http://www.dps.ny.gov>), a prospective party should click on "Search." On the Search page, the "Search by Case Number" box should be filled in with the number for this case (03-T-1385). This will bring the user to the main Document and Matter Management (DMM) page for this case. On that page, the prospective party should click the button at the upper right labeled "Request for Party Status" to see a web page with instructions for the procedures to follow to become a party. The timeframe for filing a request to be a party to this case is throughout the pendency of the case.
